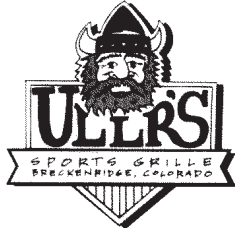

To participate on the trip every participant must complete an application in full, sign it, and make all payments on time. EAI acts only as an agent for passengers in arranging transportation and accommodations. Air/Bus carriers and hotels are not agents or employees of EAI, but are independent contractors over whom we have no direct control. Except for negligence on our part, EAI shall not be liable for any claims, losses, damages, cost or expenses arising out of, but not limited to (a) sickness, injury, accident, or death, (b) damage, loss, delay or theft of baggage or other property, (c) inconvenience or loss of enjoyment (d) injury to property or person, (e) weather, (f) flight delays, changes in the itinerary or schedule, canceled or missed air connections, (g) any factors or causes beyond our control. Our liability should in no case be greater than a full refund for the amount paid.

**INSURANCE**- We recommend you purchase baggage, and health/accident insurance.

**PRICES**- Prices represent cash/check price, and are subject to change until paid in full. Trip price will vary with respect to how many people are occupying a room. To obtain a certain price, it is your responsibility to have the necessary number of participants staying in your room. If one of the participants cancels, their roommate's trip prices will vary. No refund or trip tickets will be given out until these differences have been paid. Trip price includes no meals, drinks, cover charges, or other incidentals. Parties listed are subject to change.

**ROOM ASSIGNMENTS**- Proper room assignments must accompany all reservation forms. If we receive incomplete info, we will make your rooming assignments, and will charge you accordingly. Roommate changes at the your request must be done in writing. In some instances we will try to arrange at the customer's request for roommates, but will not make any guarantees or assume any responsibilities.

**Damage Deposit** - A \$25 per person damage deposit is due at final payment. The total deposit will be refunded within 90 days after departure provided there

is no excessive damage or cleaning to your room, public areas, bus, or areas responsible by the U.B. Ski group. The management company may collect an additional security deposit in the form of a credit card charge or cash. The security deposit will be refunded provided there is no excessive damage or cleaning to your room. Within 2 hours of check-in to your room the occupants of the unit must complete and return the room condition form to the hotel/condo management or U.B. Ski to ensure a deposit refund. Before checking out it is your responsibility to pay all room damages. If you can not pick up your deposit in person, send a stamped, self-addressed envelope to U.B. Ski.
